- 6. Discussion and reports on old business
- Bill Dahl gave a brief summary of events at the business office, including hiring of new personnel: Katrina Adams, education coordinator; Birgit Spears development; Beth Parda Primer Notes and Protocols editor.
- Financial Advisory committee has had intensive discussion of long-term financial sustainability of BSA.
- Hiring of development person is an important new step for society. Bill thinks
  that the time is right because the BSA has more diverse "selling points". Journal now
  in PubMed, Planting Science getting awards, student involvement very active.
- Membership is over 3000, about 1/3 students. Botany is thriving.
- Membership- Bill recommends that we hold membership rates at 2012 levels,

continue with student and post doc rates at ? \$10 if they renew membership early. Faculty can give 10 dollar memberships to new students. This will be discussed at business meeting. Council gave their endorsement of these proposals.

- AJB individual subscription rates will stay the same. Institutional subscription rates have gone up 4.9%.
- Print rates up 4.5% for US institutions, 7.3% for Canada/Mexico, and 6.9% for international
- Ann Hirsh and Ann Sakai received NSF PLANTS grant. 20K per year for next 5
  years to bring undergraduate students to meetings. Pam Soltis has used her own
  NSF funding to bring women students to the BSA meetings.
- BSA supports services for other societies: American Fern Society, Society for Economic Botany, Society for the Study of Evolution. These societies are paying us for this service and this pays about 3/4 of a staff position.
- Sustainability of sections: Bill wants to discuss with individual sections mechanisms to maintain activities.
- Planting Science will be changing—BSA wants to build a pipeline for students to
  end up in University. Planting Science was invited to come to meet with OSTP! They
  discussed how to make science in the classroom exciting.
- Education committee is working with ESA, SSE, and others to create web site repository for teaching botany resources. It will all be peer reviewed. Committee will need reviewers and submitters.
- US Science and Engineering Festival in April 2012. BSA will participate again. Board needs to think about what we should do as an exhibit. Teaching Section is taking lead. We are trying to link up with other plant societies. ASPB is an obvious partner. Hands on activities are most effective.
- Space: Business office has been at the Mo Bot for 8 years. No maintenance on the building in all of that time. The building is in very bad shape. Bill is working with Mo Bot to attend to the building. If they do not respond, we will have to find a different home for the business office.
- New Public Policy Committee-Kent Holsinger is chair. Some activities:
   Testimony to House appropriations committee, currently preparing comments to NSB on NSF's proposal for new evaluation criteria for proposals. Kent went to Hill as part of a larger plant science group. Committee welcomes suggestions from the membership about what BSA should weigh in on.
- Student involvement in public policy. One activity was a letter addressing confidence in NSF's peer review and funding process. Signed by thousands of students. Letter sent to congress. (letter can be viewed at BSA web site).
- Committee charges have all been rewritten. See policy section on BSA web site. All committee members should make sure that they review these.
- Society bylaws have been rewritten. Sections should review their own bylaws to make sure that they are consistent with BSA bylaws.

#### 5. New Business

A. Corresponding Members: John Dransfield from Kew Botanical Garden.

B. Awards – Board would like awards committee to aggressively pursue nominations. Sections should contribute.

Bill suggested that sections make sure that all award funds are in good shape and can support the monetary awards given. This stimulated a discussion of who is responsible for the finances of the awards. Amy Litt (treasurer) outlined three different types of awards: BSA wide awards, Sectional awards that are specific to sections and have endowments but the awards are administered by committees appointed by the Board, Awards from sections that don't have an endowment (paid for from money from BSA or other sources). The BSA and sections do not have a good mechanism for discussing and deciding on whether the amount of these awards should be increased. Resolution: oversight of society administered awards is not sectional responsibility, but sections might be encouraged to donate to awards associated with their sections. This discussion led to an:

**Action Item:** New project for Board to examine awards committees. What is the chain of command? Document how awards are administered. Steve Weller volunteered to see this project through.

Planting Science will be selling point; an example of what we do as a society. BSA needs members to help represent society in their part of the country. Legacy Society-70 people who have made a commitment to include BSA in their will. Living Legacy-Pledge to give \$100 year in perpetuity

Other suggestions-tape some of the seminars and put on web site and you tube.

For all student Award winners, we need ASAP!!! Name of award, name of student, title, mentor, institution.

Future meetings: 2012 Columbus July 7-11, With CBA 2013 New Orleans 2014 or 2015 have meeting over a Friday to host NPR Science Friday Minneapolis, Santa Fe, Boulder were suggested as future sites
